

## OUT-OF-STATE VETERAN TUITION WAIVER FORM

Effective July 1, 2014, and applicable Fall Term 2014 and thereafter, House Bill 7015 [amended section (s.) 1009.26, Florida Statutes (F.S.), *fee waivers*] created the *Congressman C.W. Bill Young Veteran Tuition Waiver Program*, which authorized an out-of-state fee waiver for honorably discharged veterans of the United States Armed Forces, United States Reserve Forces, the National Guard who physically reside within the state of Florida while enrolled at Florida State College at Jacksonville. It also now waives eligible dependents during that current term they are requesting the waiver. Dependents need to be physically residing in Florida to receive the waiver.

**Applicants for this waiver must meet the following eligibility criteria:**

- Be honorably discharged veterans of the United States Armed Forces and Reserve Forces (Air Force, Army, Coast Guard, Marines and Navy), and the National Guard (Army and Air) or any other student who is entitled to and uses educational assistance provided by the United States Department of Veterans Affairs who physically resides in Florida while enrolled as a degree or certificate seeking student.
